**Structure and Composition** The shoe cover is made of 35gPP, with elastic for fixing.

2. Organize the shoe covers to make sure that the shoe covers are all on the feet.

**Storage** It should be stored in a clean room with relative humidity not exceeding 80%, no corrosive gas, stored in a cool, dry and well ventilated.
