




You have purchased an aid designed to facilitate disabled users. Any other use is prohibited. Use only in a seated position and never stand up, for assembly refer to the explanatory images below.



Assembly instructions

- Fig. 1. Open the package and assemble the chair as shown in the figure. Secure with screws and bolts
- Fig. 2. Insert the toilet bowl in the direction indicated by the arrow.
- Fig. 3. Cover with the appropriate cushion after use.



Assembly instructions

- Fig. 1. Open the package and insert the armrests and footrests and the backrest on the main body of the frame. Fasten the backrest with the bolt.
- Fig. 2. Adjust the height of the footrest by the screw according to the user's need and then tighten the screw.
- Fig. 3. Before use please push down the brake of the wheels, rotate the footrest as Fig. 3 until the footrest is locked.

Safety and maintenance

- 1. Before use, please check all the screws are tighten and the main frame is stable. The maximum load weight is 100 kg.
- 2. Placed in ventilation place.
- 3. Verify that the test leads are in good condition. If necessary, replace them immediately if worn or missing.
- 4. Add the lubricating oil to the transmission parts regularly.

Cleaning

Use damp cloth with normal detergents. Do not submerge the seat in the bath water; drain after use and dry the seat. Don't use harsh abrasives or bleach based cleaners.
